Other Terms and Conditions for Engagement:

1. All candidates will essentially proficiency in Bengali (reading and writing) and should be Indian citizen.
2. Selected Candidates will be engaged purely on contractual basis for a period of 6(six) months subject to periodic evaluation of performance by the authority concerned and co- terminus with project period.
3. The successful candidate shall not at any point of time, claim to be made permanent.

The monthly consolidated remuneration to the candidates will be paid from the fund under "Support to State Extension Programme for Extension Reforms under Sub-mission on Agriculture Extension (SMAE) of KRISHONNATI YOJANA released by the Department of Agriculture & Co-operation, Government of India from time to time.
5. The engagement will be terminated with the discontinuation of ATMA in the state of West Bengal.
6. Successful candidates engaged for the post as specified above shall be considered as a full time worker of ATMA.

5. Complete application along with all self-attested testimonials will be accepted.

Grounds of Rejection of Application form:

1. Any application form without signature, without self-attested testimonials, without passport size colour photograph of the applicant shall be rejected.
2. Any application form which is received through post/by hand after the last date of submission i.e 16/01/2026 upto 5.30 p.m. shall be rejected.
3. Any application form which is incomplete in nature shall be rejected.
4. The candidature of candidate, who submits more than one application for a single post will be cancelled even he/she is eligible for the same.

Selection Procedure:

1. All the eligible candidates will be called for interview for final selection.
2. Call letter for interview will be sent through e-Mail of the concern candidate.
3. Merit list will be prepared by the considering percentage of marks obtained in academic qualification & marks obtained in Interview.
4. Final Selection will be made by considering ---
 - i) 70 percentile for Academic qualification.
 - ii) 30 percentile for Interview.
5. In case of Computer Programmer, B.Tech./MCA will get same weightage.
6. Computer test may be conducted for the post wherever applicable.
